**TARGETS: 100 YARD REDUCED TARGETS, SR-1, SR-21, AND MR-31**

**COURSE OF FIRE:**

- MATCH 1...2 SS, 10 SHOTS STANDING SLOW FIRE 10 MINUTES FOR RECORD**
- MATCH 2...2 SS, 1 10-SHOT STRING, SITTING RAPID FIRE 60 SECONDS**
- MATCH 3...2 SS, 1 10-SHOT STRING, PRONE RAPID FIRE 70 SECONDS**
- MATCH 4...2 SS, 20 SHOTS PRONE SLOW FIRE 20 MINUTES FOR RECORD**
- MATCH 5...RAPID FIRE AGGREGATE (MATCHES 2 AND 3)**
- MATCH 6...SLOW FIRE AGGREGATE (MATCHES 1 AND 4)**
- MATCH 7... GRAND AGGREGATE (MATCHES 1 THROUGH 4)**

**RIFLES: ANY SAFE CENTER FIRE RIFLE CAPABLE OF RAPID FIRE WITH MAGAZINE/STRIPPER CLIP CHANGE (RULE 3.3)  
THERE WILL BE A SEPARATE RIMFIRE CLASS AVAILABLE (SCORES NOT REPORTED TO NRA)**

**SIGHTS: THIS IS AN ANY-SIGHT MATCH IN ACCORDANCE WITH RULE 3.3.2**

**AMMUNITION: COMPETITORS WILL FURNISH OWN AMMUNITION**

**SCORING: COMPETITORS WILL SCORE TARGETS**

**AWARDS SCHEDULE: AWARDS WILL BE PRESENTED ON THE BASIS OF 1ST--3 OR MORE IN A CLASS; 2ND--5 OR MORE IN A CLASS; 3RD--8 OR MORE IN A CLASS.**
